Notice of Public Open House Short Term Rental Land Use Study

PURPOSE:

The Fort Erie Short-Term Rental Pilot Program was initiated in 2020 with updates ongoing to refine and regulate the short-term rental industry operating in the Town of Fort Erie.

There is currently a moratorium on accepting new Short-Term Rental applications until the results and recommendations of a Town initiated Land Use Study have been approved by Council and any subsequent amendments to the Town's Official Plan and Zoning By-law have been undertaken. The Town has retained WSP Canada Inc. to undertake the study, which is targeted for completion in early 2023.

This Open House will invite the community to ask questions and express opinions on the short-term rental industry operations within the Town and more specifically, how the Town should set out to regulate such aspects as permitted location(s) for short-term rentals, number of licences and any other regulatory limitations that may be appropriate.

The study aims to develop and recommend a land use approach to directing and regulating short-term rentals within the Town's boundaries. The work will entail in-depth research and public engagement followed by the development of several options for consideration and ultimately, recommendations being made to Town Council. This study will not review enforcement or the licencing process, but is strictly focused on land use.

This Open House is the first of several opportunities for public consultation and feedback that will help inform any recommendations made to Council.
