BY-LAW NO. 153-2001

BEING A BY-LAW TO AUTHORIZE THE ACCEPTANCE OF AN RFP FOR RECONSTRUCTION OF COURTS AT FORT ERIE TENNIS CLUB

WHEREAS the Fort Erie Tennis Club requested permission from the Town to reconstruct four of the original courts at the Fort Erie Tennis Club located on Central Avenue, and

WHEREAS the Fort Erie Tennis Club issued a Request for Proposal and received three RFP's to complete this work, and

WHEREAS the following RFP's were received for this specialized work:

1. Court Contractors Ltd.	\$ 93,700.00 + g.s.t.	4 year guarantee
2. Tennex Systems Inc.	\$ 74,950.00 + g.s.t.	1 year guarantee
3. Barber Sports Surfaces	\$118,270.00 + g.s.t.	1 year guarantee
4. Colour Court Recreation Const.	\$124,700.00 + g.s.t.	2 year guarantee, and

WHEREAS the Fort Erie Tennis Club at its meeting of July 28th, 2001 recommended acceptance of the RFP from Court Contractors Ltd. in the amount of \$93,700.00 + g.s.t. since the Fort Erie Tennis Club prefer reconstruction utilizing the penetration asphalt system provided by Court Contractors Ltd., and

WHEREAS Report No. PCS-94-2001 was approved at the Council-in-Committee meeting of August 13th, 2001 authorizing the acceptance of the quotation/RFP from Court Contractors Ltd. of Mississauga, Ontario in the amount of \$93,700.00 + g.s.t. for the reconstruction of courts 1 to 4 at the Fort Erie Tennis Club located on Central Avenue and that the Purchasing and Tendering Policy By-law No. 191-95 be waived, and

WHEREAS it is deemed desirable to accept the aforesaid RFP received from Court Contractors Ltd.;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** the Request for Proposal received from Court Contractors Ltd. of Mississauga, Ontario in the amount of \$93,700.00 + g.s.t. for the reconstruction of courts 1 to 4 at the Fort Erie Tennis Club be and it is hereby accepted and approved.

2. THAT the Mayor and Clerk be and they are hereby authorized and directed to execute any documentation necessary to complete this project.
3. THAT Purchasing and Tendering Policy By-law No. 191-95 be and it is hereby waived due to the specialized nature of the project.
