BY-LAW NO. 62-2002

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF A CORRECTING DEED 929 BOWEN ROAD (BEAR CONSTRUCTION INC.) (120902)

WHEREAS by Instrument No. 376577 registered on the 28^{th} day of August 1981 Benjamin Carl Roland Anger and Holly June Anger purchased lands from the Town of Fort Erie described as all of Lots 204 - 221 inclusive on Plan 451 with the condition that the lands merge with the adjoining lands owned by the grantees, and

WHEREAS by Instrument No. 483768 registered on October 14th, 1986 Benjamin Carl Roland Anger and Holly June Anger conveyed the property to Benjamin Carl Roland Anger consisting of Lots 204 – 221 inclusive on Plan 451 as well as the adjoining parcel, being Part Lot 8, Concession 3, Niagara River, designated as Part 1 on Plan 59R-3512, and

WHEREAS by Instrument No. 492099 registered on February 6th, 1987, the Corporation of the Town of Fort Erie registered a Notice of Forfeiture, which said notice included Lot 204, Plan 451, and

WHEREAS Lots 205 – 219, Lots 220 and 221, Plan 451, Bertie and Part Lot 8, Concession 3, Niagara River, being Part 3 on Plan 59R-3512 was converted from the Registry system to the Land Titles system on the 13th day of December 1999 and assigned Property Identification No. 64235-0021 (LT) and Benjamin Carl Roland Anger is shown as the owner, and

WHEREAS Lot 204, Plan 451, Bertie was converted from the Registry to the Land Titles system on the 15th day of December 1999 and assigned Property Identification No. 64235-0102 (LT) and the Corporation of the Town of Fort Erie shown as the owner on the basis of the Notice of Forfeiture registered as Instrument No. 492099, and

WHEREAS Mr. Anger has been billed for taxes and has been paying taxes on Lot 204 as well as the other lots since the property was so purchased, and

WHEREAS it has been confirmed with the Finance Department of the Town of Fort Erie that Lot 204 was erroneously included in the Notice of Forfeiture in 1987, and

WHEREAS by Instrument No. LT 172664 registered on December 22, 2000 Benjamin Carl Roland Anger conveyed the property to Bear Construction Inc. described as Lots 205-221 inclusive, Plan 451 Bertie and Part Lot 8, Concession 3, Niagara River, Bertie being Part 3 on Plan 59R-3512, and

WHEREAS it is deemed desirable to grant a correcting Deed to Bear Construction Inc. at the expense of the Town;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

- 1. THAT the granting of a correcting Deed from the Town of Fort Erie to Bear Construction Inc. for Lot 204, Plan 451, Bertie in the amount of \$1.00 be and it is hereby authorized and approved.
- 2. THAT the Mayor and Clerk be and they are hereby authorized and directed to execute the correcting Transfer/Deed of Land as well as any other documentation necessary to complete this transaction.
- 3. THAT the costs associated with the granting of the correcting Transfer/Deed of Land to Bear Construction Inc. shall be borne by the Corporation of the Town of Fort Erie.
