**BEING A BY-LAW TO ACCEPT A TENDER FOR

CONTRACT NO. IS.07RSRF (H)

**WHEREAS** tenders were advertised and publicly opened on Tuesday, May 15, 2007 for Road Resurfacing – Hot Mix Asphalt – Contract No. IS.07RSRF (H), the results of which are as follows:

**WHEREAS** at the Council-in-Committee meeting of May 22, 2007 Report No. IS-25-07 was accepted and approved authorizing the awarding of the tender for Road Resurfacing – Hot Mix Asphalt - Contract No. IS.07RSRF (H), to Norjohn Contracting & Paving Ltd. of Thorold, Ontario in the amount of \$282,215.04 including G.S.T., and


**WHEREAS** it is deemed desirable to accept the tender from Norjohn Contracting & Paving Ltd. for the aforesated works and price;

**NOW THEREFORE** the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** the tender received from Norjohn Contracting & Paving Ltd. in the amount of \$282,215.04 including g.s.t., for Road Resurfacing – Hot Mix Asphalt - Contract No. IS.07RSRF (H) be and it is hereby accepted and approved.
2. **THAT** the entry into an Agreement with Norjohn Contracting & Paving Ltd. in the amount of \$282,215.04 including g.s.t., for Road Resurfacing – Hot Mix Asphalt - Contract No. IS.07RSRF (H) in the form of Schedule “A” annexed hereto to this by-law be and it is hereby authorized and approved.

3. **THAT** the Mayor and Clerk be and they are hereby authorized and directed to execute the Agreement.
4. **THAT** pursuant to the provisions of Sections 23.1 to 23.5 of the Municipal Act, 2001, as amended, the Clerk of the Town of Fort Erie is hereby authorized to effect any minor modifications or corrections solely of an administrative, numerical, grammatical, semantical or descriptive nature or kind to this by-law or its schedules as such may be determined to be necessary after the passage of this by-law.
