GENERAL CONTRACTING LTD FOR THE EAST AVENUE

**WHEREAS** tenders were advertised and publicly opened on January 15, 2009 for the East Avenue Watermain Replacement – Contract No. IS.09EAST, the results of which were as follows,

**WHEREAS** at the Council-in-Committee Meeting of January 26, 2009 Report No. IS-02-09 was accepted and approved authorizing the awarding of the tender and the entry into an agreement with DeRose Bros. General Contracting Ltd. of Thorold, Ontario for the East Avenue Watermain Replacement – Contract No. IS.09EAST in the amount of \$281,259.72 including 5% g.s.t., and

**WHEREAS** it is deemed desirable to accept the tender and authorize the entry into an agreement with DeRose Bros. General Contracting Ltd. for the aforesated works and price;

**NOW THEREFORE** the Municipal Council of the Town of Fort Erie hereby enacts as follows:

1. **THAT** the tender received from DeRose Bros. General Contracting Ltd. in the amount of \$281,259.72 including 5% g.s.t., for the East Avenue Watermain Replacement – Contract No. IS.09EAST be hereby accepted and approved.
2. **THAT** the entry into an agreement with DeRose Bros. General Contracting Ltd. for the East Avenue Watermain Replacement – Contract No. IS.09EAST in the form of Schedule “A” annexed hereto to this by-law be hereby authorized and approved.
3. **THAT** the Mayor and Clerk be and they are hereby authorized and directed to execute the agreement annexed hereto as Schedule “A” to this by-law and to affix the corporate seal thereto.
4. **THAT** pursuant to the provisions of Sections 23.1 to 23.5 inclusive of the Municipal Act, 2001, as amended, the Clerk of the Town of Fort Erie is hereby authorized to effect any minor modifications or corrections solely of an administrative, numerical, grammatical, semantical or descriptive nature or kind to this by-law or its schedules as such may be determined to be necessary after the passage of this by-law.
