BY-LAW NO. 33-09

BEING A BY-LAW TO AWARD TENDERS TO B. PATTERSON CHRYSLER JEEP OPERATED BY B. PATTERSON GARAGE INC. AND WAJAX INDUSTRIES INTEGRATED DISTRIBUTION SYSTEMS LP FOR THE PURCHASE OF REPLACEMENT VEHICLES

WHEREAS the 10-Year Fleet Replacement Plan was approved under Report No. PW-10-04 at the Council-in-Committee Meeting of February 2, 2004, and

WHEREAS Council adopted the 2009 Preliminary Capital Budget at the Council Meeting of December 8, 2008 to authorize the 2009 Fleet Replacement Plan, and

WHEREAS three tenders were advertised and publicly opened on February 11, 2009 for a replacement 2008 full size 8 cylinder 4x4 Pick-up Truck, 2009 4x4 Backhoe with Attachments and 2009 Mini Van, and

WHEREAS at the Council-in-Committee Meeting of February 17, 2009 Report No. IS-12-09 was approved authorizing that the 2009 Replacement Vehicle tenders in the total amount of \$140,000.00 including p.s.t., trade-in allowances and the retrofit of vehicles and excluding g.s.t. be awarded;

NOW THEREFORE the Municipal Council of the Town of Fort Erie hereby enacts as follows:

- 1. THAT the tender received from B. Patterson Chrysler Jeep operated by B. Patterson Garage Inc. of Fort Erie, Ontario for a new 2008 full size 8 cylinder 4x4 Pick-up Truck in the amount of \$24,211.00 (including p.s.t. and trade-in allowance and excluding the retrofit of vehicle and g.s.t. be and it is hereby authorized and approved.
- 2. THAT the tender received from Wajax Industries Integrated Distribution Systems LP of Mississauga, Ontario for a new 2009 4x4 Backhoe with Attachments in the amount of \$86,088.30 (including p.s.t. and trade-in allowance and excluding the retrofit of vehicle and g.s.t.) be and it is hereby authorized and approved.
- 3. THAT the tender received from B. Patterson Chrysler Jeep operated by B. Patterson Garage Inc. of Fort Erie, Ontario for a new 2009 Mini Van in the amount of \$19,376.28 (including p.s.t. and trade-in allowance and excluding the retrofit of vehicle and g.s.t.) be and it is hereby authorized and approved.
