BY-LAW NO. 12-11

BEING A BY-LAW TO AMEND BY-LAW NO. 136-10 (APPOINT PERSONS TO VARIOUS BOARDS AND COMMITTEES OF THE TOWN OF FORT ERIE)

WHEREAS By-law No. 136-10 was passed by the Municipal Council of the Town of Fort Erie on the 13th day of December, 2010 to appoint persons to various boards and committees of the Town of Fort Erie, and
