BY-LAW NO. 10-2015

BEING A BY-LAW TO APPOINT PERSONS TO VARIOUS BOARDS AND COMMITTEES OF THE TOWN OF FORT ERIE, TO AMEND BY-LAW NOS. 180-07, 23-10 AND 145-06, AND TO REPEAL BY-LAW NOS. 136-10, 12-11, 35-11, 55-11 AND 109-11

WHEREAS Section 18 of Council Rules of Procedure By-law No. 145-06, as amended, provides for the appointment of members to the authorities, committees, boards and commissions requiring resident, business owner/operator or taxpayer and Council appointments to the various boards and committees of the Town of Fort Erie, and

WHEREAS Section 18.6 of the said by-law provides the term shall be for a term of four years commencing February 1st in the year following the Inaugural Meeting of Council and ending January 31st in the year following the next Inaugural Meeting save and except the Committee of Adjustment, Fort Erie Public Library Board, as provided for under the *Planning Act* and the *Public Libraries Act* respectively, and the Niagara Parks Commission whose term shall be concurrent with the Council, and

WHEREAS By-law No. 180-07 was passed by the Municipal Council of the Town of Fort Erie on the 13th day of November, 2007 to re-establish the Bridgeburg Station Downtown Business Improvement Area and to make re-appointments thereto and the Board of Management has requested to increase the composition from "6 citizen appointees" to 8 citizen appointees," and

WHEREAS By-law No. 145-06, as amended was passed by the Municipal Council of the Town of Fort Erie on the 21st day of August, 2006 to Adopt Council Rules of Procedure and due to the request by the Bridgeburg Station Downtown Business Improvement Area to increase its composition it is deemed necessary to amend Section 2 of "Part 1 – External" of Appendix "E" to By-law No. 145-06, and further

WHEREAS By-law No. 23-10 was passed by the Municipal Council of the Town of Fort Erie on the 22nd day of February, 2010 to establish and appoint members to the Senior Citizens Advisory Committee and a request has been received from the Beachcombers of Ridgeway to increase its representation from "2 members" to "3 members" since their membership is more than 300 members, and

WHEREAS By-law No. 145-06, as amended was passed by the Municipal Council of the Town of Fort Erie on the 21st day of August, 2006 to Adopt Council Rules of Procedure and due to the request by the Beachcombers of Ridgeway to increase its representation it is deemed necessary to amend Section 22 of "Part 1 – External" of Appendix "E" to By-law No. 145-06, and further

WHEREAS By-law No. 136-10, as amended was passed by the Municipal Council of the Town of Fort Erie on the 13th day of December, 2010 to appoint persons to various boards and committees of the Town of Fort Erie and to repeal By-law No. 167-08, and

WHEREAS pursuant to Section 18.3 of By-law No. 145-06, as amended at a Special Council-in-Committee Meeting held January 12, 2015 recommendations were made for the appointment of persons to the various boards and committees, and

WHEREAS it is deemed necessary and expedient to appoint persons to the various boards and committees as well as to enact minor amendments to various by-laws;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:



- 5. THAT Section 2 of "Part 1 External" of Appendix "E" to By-law No. 145-06, as amended, (To Adopt Council Rules of Procedure) be amended by deleting "6 citizen appointees" and inserting the following thereto:

"8 citizen appointees."

6. **THAT** Section 3 to By-law No. 23-10 (To Establish and Appoint Members to the Senior Citizens Advisory Committee) be amended by inserting the following thereto:

"Seniors Group with more than 300 members - 3 Committee Members" and by deleting "2 reps – "Beachcombers of Ridgeway;" and inserting in lieu thereof "3 reps – Beachcombers of Ridgeway."

7. **THAT** Section 22 of "Part 1 – External" of Appendix "E" to By-law No. 145-06, as amended, (To Adopt Council Rules of Procedure) be amended by inserting the following thereto:

"and three (3) Committee members to be nominated by each Seniors Group in the Town of Fort Erie with more than three hundred (300) members."

- 8. THAT By-law Nos. 136-10, 12-11, 35-11, 55-11 and 109-11 be hereby repealed.
- **9. THAT** pursuant to the provisions of Sections 23.1 to 23.5 inclusive of the *Municipal Act, 2001,* as amended, the Clerk of the Town of Fort Erie is hereby authorized to effect any minor modifications or corrections solely of an administrative, numerical, grammatical, semantical or descriptive nature or kind to this by-law or its schedules as such may be determined to be necessary after the passage of this by-law.
