



# The Municipal Corporation of the Town of Fort Erie

## By-law No. 110-2018

---

### Being a By-law to Assume Secondary Services in the Brian Street Development Part of Plan 492 and Part of Plan 426 (Plan 59R-11562) (Dexter Developments Inc. – Sam Morabito)

---

**Whereas** By-law No. 241-04 authorized the Mayor and Clerk to execute the Development Agreement for the Brian Street Development; and

**Whereas** Section 10.8 of the Development Agreement provides that municipal services shall be assumed by the Town in two stages, namely, by Council first passing an Assumption By-law for Primary Services after the Director of Infrastructure Services approves the Certificate of Final Acceptance for Primary Services, and second, an Assumption By-law for Secondary Services after the Director of Infrastructure Services approves the Certificate of Final Acceptance for Secondary Services; and

**Whereas** pursuant to the Development Agreement, Secondary Services includes all finished streets and roadways as constructed by the Developer in accordance with the Plan of the Development Agreement; and

**Whereas** the Director of Infrastructure Services has approved the Certificate of Final Acceptance for Secondary Services for the said development; and

**Whereas** it is deemed desirable to assume the Secondary Services installed pursuant to the Development Agreement, including the highways within the Plan of the Development;

**Now therefore** the Municipal Council of the Town of Fort Erie enacts as follows:

1. **That** the following Secondary Services identified on the approved servicing plans for the Brian Street Development, registered as Plan No. 59R-11562, Part of Plan 492 and Part of Plan 426 are assumed by the Town of Fort Erie, namely:
  - a) Municipal Roads (including boulevards);
  - b) Driveway Aprons;
  - b) Sidewalks;
  - c) Fencing; and
  - d) Landscaping

pursuant to the Certificate of Final Acceptance for Secondary Services dated July 13, 2018.

2. That the following parcels of land situated in the Town of Fort Erie are assumed as public highway:

3. That the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
