By-law No. 2-2019

Being a By-law to Appoint Persons to Various Boards and Committees

Whereas Section 19 of Council Rules of Procedure By-law No. 36-2016 provides for the appointment of members to various Boards and Committees for particular purposes; and

Whereas By-law No. 10-2015, as amended was passed by the Municipal Council of the Town of Fort Erie on the 19th day of January, 2015 to appoint persons to various Boards and Committees of the Town of Fort Erie; and

Whereas Recommendation No. 1 was approved at the Inaugural Special Council Meeting held on December 3, 2018 to recommend Leah Feor to The Regional Municipality of Niagara's Council as the Town of Fort Erie representative for appointment to the Niagara Peninsula Conservation Authority for the 2018-2022 term of Council; and

Whereas By-law No. 148-2018 was passed by the Municipal Council of the Town of Fort Erie at the Inaugural Special Council Meeting held on December 3, 2018 to appoint the Mayor as the Town of Fort Erie representative to the Niagara Parks Commission; and

Whereas at the Special Council-in-Committee Meeting held on January 8, 2019, recommendations were made for the appointment of persons to various Boards and Committees for the period ending November 14, 2022; and

Whereas Recommendation No. 6 was approved at a Special Council-in-Committee Meeting held on January 8, 2019 to increase the composition of the Communities-in-Bloom Committee by one (1) member to twelve (12) citizen appointees; and

Whereas By-law No. 1-2019 was passed on January 14, 2019 by the Municipal Council of the Town of Fort Erie to effect the increase in the composition of the Communities-in-Bloom Committee; and

Whereas it is deemed necessary and expedient to appoint persons to the various boards and committees;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:
