

# The Corporation of the Town of Fort Erie By-law 72-2024

### Being a By-law to Authorize Applications for the Cancellation, Reduction or Refund of Taxes Levied for the Years 2022, 2023 and 2024

**Whereas** pursuant to Sections 357 and 358 of the *Municipal Act, 2001*, as amended, an owner or another person with an interest in a property may make application for the cancellation, reduction or refund of taxes levied in respect of an event that affects the assessment or an overcharge; and

**Whereas** Report CS-04-2024 was considered and approved at the Council-in-Committee Meeting held June 10, 2024 for the cancellation, reduction or refund of taxes and penalties in the amount of \$56,545.09

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- **1.** That the applications received for tax adjustments totalling \$56,545.09 for various roll numbers attached as Schedule "A" to this by-law, are accepted and approved.
- 2. That the Clerk of the Town is authorized to affect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
