The Region is responsible for water treatment, trunk water main facilities, water storage, and residual disinfection. The Town owns and operates the Fort Erie Distribution System, purchasing water from the Region and supplying it to serviced areas within all urban and settlement areas of the Municipality. The distribution system is a Class 2 system, extending westerly as far as Pt. Abino through Ridgeway and Crystal Beach and northerly to Douglastown through Stevensville.
