1. Call to Order

Mayor Redekop called the meeting to order at 6:00 p.m.

Mayor Redekop acknowledged the land on which we gather is the traditional territory of the Haudenosaunee, Mississaugas of the Credit, and Anishinaabe people, many of whom continue to reside in this area.

Mayor Redekop made the following announcements:

Year End Remarks

This is the last meeting for the year before Christmas for this Council.

We've had an interesting 2 years considering the Pandemic and the odd situation that we have all been living in for elected officials who like to shake hands and pat people on the back and arm. It's been a challenge that we can't get close to people.

I am looking forward to continuing the work with this Council and Staff. There will be some major changes in our Staff in the New Year but I'm sure that we will continue on in the same great fashion that we have for the last 3 years.

Storm the Past Weekend

Once again Mother Nature has reared her head to let us know that there's one controlling factor in life, in nature, and that's Mother Nature.

I want to thank Town Staff, the Fire Department, and Canadian Niagara Power for the work that they did over this weekend, trying to make sure that people were safe, that property to the extent possible was protected, and that people had electricity when they needed it. It was a great challenge. At one time there were 9 areas where trees had fallen on hydro lines or knocked out poles, and at one point I think almost the whole Town was without electricity when they needed it. This morning there were still pockets of individuals that didn't have electricity but the Canadian Niagara Power crews along with some of their colleagues from outside the area were continuing to work on that. Town Staff worked throughout the night and on the weekend and were quite intrepid in their efforts, and I want to thank them for being on top of this, and of course, the Fire Department did its usual thing, and I would like to thank them as well for their work.

The message is clear, climate change is upon us. Things that we used to do we're going to have to change. Things that we thought were normal are no longer normal, and so later on in the Agenda we will be raising some of those topics and looking at perhaps how we can move forward to better adapt to the climate change that's occurring. We received a report in October of 2020 from Bev Bradnam, Assistant to the CAO, so we will be taking a look at that as well.

7. Regional Councillor Report

RC Insinna gave the following Report:

There are changes to the garbage collection during the holiday season. During the week of December 27 to the 31, residents of Fort Erie that are living in single-family homes and those living in apartments with 6 units or less are now going to be able to put out 4 bags of garbage on their normal collection day.

During the week of January 10th to 14th Niagara Region will be collecting Christmas Trees, please remember to have people to remove their decorations and don't put it in a plastic bag because they will be composting everything.

There has been a lot of discussion and debate with regard to the Regional Official Plan and how it will protect our environment. At a Committee of the Whole Meeting, Regional Council was again at crossroads regarding the Natural Environment System and the options that were put forward to us regarding 3B and 3C or regarding Natural Heritage Systems. Option 3C was unanimously approved which would give the best chance for the protection of our environment as it would protect the buffer zones in all areas preserving our wetlands and systems. The matter will go before Regional Council this Thursday.

The budget deliberations have come to an end at the Region. The Budget Committee of the Whole has recommended an increase of 2.87% and this will be going to Regional Council on Thursday for ratification. In order to get to this point, Regional Council dipped into the Tax Payer Relief Fund in order to bring down the initial percentage of 4.35%.

Later in the Agenda, Council will be dealing with the Niagara Transit Consolidation. As Council knows, it's taken a lot of years to get to this point and I would like to express my sincere thanks to Council in moving forward with this.

I would like to take this opportunity to thank all Council and Staff for their support during these unprecedented times, this year has been a challenge for everyone and you are all to be commended on your leadership and guidance during the pandemic. On behalf of my family, I would like to wish you all a Merry Christmas, Happy Holiday and a safe and prosperous New Year. Councillor Noyes advised she received a call that there was an expansion of the lagoon and asked if RC Insinna had any information on that. RC Insinna suggested that it could be the \$4 million work that was slated to happen.

Councillor Noyes advised she understood the \$4 million was to remove the sludge, and this gentleman was referring to expansion. RC Insinna responded that he would get back to Councillor Noyes.

Councillor Butler referred to the buffer zones and the preserving of the environment. She asked if the Region has looked at their commitment to address the flooding areas such as Shirley Road. RC Insinna responded that he has brought the area up with Public Works and they did increase the pump sizes. RC Insinna advised he will look into to it to see if the NPCA has done any of the mapping with regards to that area.

Councillor Butler asked RC Insinna to find out if the pump sizes have in fact been replaced, and if they are looking to fix the problem this weekend. RC Insinna advised that he would look into it.

8. **Presentations and Delegations**

(a) Doug Swift, Fort Erie Community Preservation Coalition

Re: PDS-106-2021 Land Use Controls and Legal Review of Short-Term Rentals

Mr. Swift provided the following commentary:

- The Fort Erie Community Preservation Coalition appreciates the opportunity that Council provided them to sit down with Staff and to share their thoughts on how Short-Term Rentals are to be best addressed from a land use perspective.
- We share Staff's opinion on the benefits of a comprehensive Official Plan Policy and Zoning By-law provisions to guide the use of Short-Term Rentals as a land use.
- We hope that you will accept the recommendations to refer the hiring of a consultant to the deliberation of the 2022 Operating Budget.
- The use of Short-Term Rentals is a very serious issue for the whole Town.
- Most of the Reports and the recommendations that come from staff, have come from the lens of Economic Development.
- We are now seeing a Report from the Planning Department which considers the entire community's expectations.

- We request that you accept the Report as part as the next step in the zoning process.
- This is a very complex and emotional issue, and should be considered at length to get it right the first time in order to avoid any disputes down the road.
- The Fort Erie Community Preservation Coalition has grown to represent nearly 650 people and counting.
- We are working collaboratively to find the right solution in our home town.
- (b) David McPherson, 3856 Ryan Avenue

Re: PDS-106-2021 Land Use Controls and Legal Review of Short-Term Rentals

Mr. McPherson delivered a PowerPoint Presentation which is available on the Town's Website and the following commentary:

- The Report comments on the Stakeholder Consultation process, claiming consensus on certain issues.
- The Report lacks transparency as requests to obtain the underlying legal opinion were denied.
- The potential outcome that existing Short Term Rentals (STRs) are granted Legal Non-conforming status in perpetuity (including ownership changes) is unacceptable.
- The Report does not address the negative experience of STRs currently operating in South Coast Village.
- STRs in the final analysis are a commercial business and as such must be subject to a higher level of regulation and zoning.
- Consider Net Economic Growth, after accounting for the impact of full-time residents and discounting the rental income that doesn't stay inside Fort Erie.
- It is critical that the moratorium be left in place while an approach is being worked on.
- Lifting the moratorium would potentially exacerbate the issue of non-conforming properties and operators.
- It would be prudent for the Town to cease issuing licenses in areas where active consideration is given to zoning changes, especially instances where there are restrictive covenants on title.

Whereas the NPCA often collaborates with its municipal partners, government and non-government organizations, and the community to deliver on mutual goals and outcomes such as ecosystem restoration; and

Whereas the NPCA and Niagara Parks Commission have partnered to restore "Gonder's Flats" wetland which is owned by the Niagara Parks Commission and situated along the Niagara River in the Town of Fort Erie; and

Whereas the "Gonder's Flats Wetland Restoration Project" has been approved by the Niagara Parks Commission's Properties and Infrastructure Committee; and

Whereas the NPCA has secured funding from several organizations and are pursuing additional funding opportunities to implement the "Gonder's Flats Wetland Restoration Project"; and

Whereas a letter of support from the Municipal Council of the Town of Fort Erie is required from some funding sources such as the Intact Foundation's Municipal Climate Resiliency Grant; and

Whereas a letter of support from the Municipal Council of the Town of Fort Erie does not commit the Town to any funding contributions;

(j) Councillor Noyes advised she received an email from a resident regarding the recent storm, suggesting on how to improve the system on notifying FORTIS when there are power outages. It was a detailed system with an outage map that would be available on a computer or cell phone.

> Councillor Dubanow responded that there are other Hydro Utilities in Niagara which utilize apps and mapping systems which help to plot out where power outages occur. If Canadian Niagara Power does one it would be beneficial to the community and would help with cutting down on the calls.

> Councillor Noyes advised that she will send the email to Mr. Kuchyt so he can follow up with FORTIS. Mayor Redekop asked that members of Council be copied as well.

(k) Councillor Butler referred to the storm that took place over the weekend. As recent as 2019, the Mayor made a Motion that was passed by Council unanimously with respect to some changes regarding climate change. With extreme weather patterns, we need to look at more aggressive ways of combatting climate change. She asked that Staff and Council work together and put together an aggressive plan.

> Mayor Redekop responded that a Report was received in October of 2020 so there is a basis and foundation for Council to move forward with some actions with respect to how we address more frequent extreme weather events, which in some cases have a devastating impact.

Mayor Redekop advised that he has spoken to Mr. Kuchyt about possibly budgeting from Reserves for a Study as to how to move forward.

(I) Councillor Zanko advised that a member of the public advised that due to the new Animal Control By-law, in order to obtain licences for dogs, you must provide vaccination proof of a Rabies shot. Councillor Zanko advised that she thought Rabies vaccination was required before too, and would like clarification. Ms. Dolch responded that she would look into it.

A Response to Enquiry will be provided at a future meeting.

- (m) Mayor Redekop questioned the status of 477 Ridge Road. Ms. Dolch responded that staff are working through the direction that Council provided to deal with the repair of the building and the structural engineer.
- (n) Mayor Redekop advised that during the storm he noticed there were 9 areas where trees had fallen on hydro lines or knocked over hydro poles in the Town and enquired if that's a reflection of the Town's efforts of removing dead Ash Trees as a result of Emerald Ash Borer.

Mr. Kuchyt responded that the Ash Tree Removal Program first addressed all of the trees within road allowances to make sure that risk was eliminated, and later moved on to parks. It's very unlikely that the trees that took down lines are Ash Trees, and it's likely that it is one of two things – they are not Ash Trees or they are Ash Trees that are not on Town property.

Mayor Redekop asked Mr. Kuchyt if this is something that he can ask FORTIS to see what their comments are. Mr. Kuchyt responded that he would ask them.

(o) Mayor Redekop enquired about prospects of more fuel-efficient less carbon generated source of vehicles for our fleet.

Mr. Walsh responded that the larger fleet are dump trucks and run primarily on diesel fuel, and it's pretty difficult to replace that. Biodiesel is a maturing technology, and could be looked at in the future. With respect to the smaller fleet, being pickup trucks and passenger vehicles, staff are always looking for better technology. There was an experiment with a couple of hybrid vehicles a number of years ago, and the technology wasn't quite mature at the time. Staff are looking at a different fleet acquisition strategy that would improve mileage throughout the smaller fleet. With respect to electric vehicles, the availability nor the price point is what suits the Town's needs right now, but natural gas is something we could look into. The big cost is converting vehicles, but we are always looking to better the environment in a cost-effective way.

Mayor Redekop advised that he understood Mr. Walsh had contact with an organization that was trying to encourage Municipal fleets with smaller vehicles to switch over to electricity.

Mr. Walsh responded that right now electric vehicles are very hard to source and there aren't many out there. The prices he thinks, in his opinion, are outrageous right now. Over the next few years we will see the price drop and more suitable vehicles become available.
